The city of Lyon

Lyon is a European metropolitan area with a human scale and is often cited among the cities in France and Europe having the best quality of life. Listed as World Heritage by UNESCO, it subtly combines an attractive living environment and economic dynamism.

Lyon hosts leading artistic events that keep its nights lively. Each season features an event that stars talents from everywhere in the world. In the spring, Les Nuits Sonores, an increasingly famous indie and electronic music festival. Summer nights mean outdoor concerts with the jazz festival Jazz à Vienne and les Nuits de Fourvière. In the fall, you can enjoy artistic performances at the Biennial Festivals of Dance and Contemporary Art. Winter offers an artistic and technological masterpiece: la Fête des Lumières (Festival of Lights).

With its rich heritage, Lyon offers multiple places where culture has the place of honor to its residents: the Opera house, the Contemporary Art Museum, the World Puppets Gadagne museum, the Gallo-Roman museum, the Fine Arts museum, the Center for the History of the Resistance and Deportation, the Auditorium, the Maison de la Danse... along with around twenty theaters!

For sport fans, Lyon has high-ranked teams in most prominent team sports: Olympique Lyonnais for soccer, ASVEL for basketball, LOU for rugby...

Besides, Lyon is an ideal starting point to travel to ski resorts, the south of France (Provence, Côte d'Azur), Paris (two hours in TGV), and European countries such as, for instance, Italy, Switzerland and Spain.



University Diploma LL.M IN INTERNATIONAL AND EUROPEAN BUSINESS LAW

Program Overview

The university degree LL.M in International and European Business Law program offered by the Faculty of Law at the University Jean Moulin Lyon 3 is a postgraduate program, which gives students the opportunity to deepen their knowledge in international and European business law. Lectures are taught exclusively in English by scholars and practitioners specialized in law, and perfectly fulfill the requirements of international legal practice.

Objectives

- Deepen students' knowledge in law at National, European and International levels, providing them with tools to work more efficiently in a worldwide perspective
- Develop their personal and professional abilities so they can use them in their legal practice
- Encourage independent reading and research using traditional resources and specialized databases
- Guide the students in the application of legal concepts to real situations using practical case studies
- Foster group work and public speaking
- Enhance practical legal skills: pleading drafting, negotiation and communication
- Train students in presenting their ideas and arguments in complex legal fields studied orally and in writing

Curriculum Organization

The university degree LL.M in International and European Business Law offers a high-quality training spanning over one academic year, taught exclusively in English by scholars from Lyon 3 but also by academics and practitioners coming from France and overseas. Almost all courses are organized in the form of an 18-hour seminar over a week, immediately followed by the exam. This calendar allows a condensed organization of the year:

Entry Requirements

The university degree LL.M in International and European Business Law is opened to students who possess a law degree with a high academic standing from an accredited university or who have been admitted to practice law.

➤ To be eligible to apply, student must

- Possess a background in law
- Possess a law degree from an accredited university
- Have been admitted to practice law
- Have obtained either the Common Professional Examination of England and Wales with good results, provided that the candidate has also obtained at least a second class from an accredited university
- Hold another degree in a discipline other than law from an accredited university and provided that the Law School's Admissions Committee is satisfied that by reason of candidate's background, experience and professional qualifications

➤ Possess a thorough knowledge of the English language

- Applicants who are not from an English speaking country will have to satisfy the Law School's English language requirements. See our website for the language requirements: lim.univ-lyon3.fr
- Applicants who have completed at least one year of education in a country where English is the official language are not required to provide an English score test, a document stating the duration and location of courses attended is required.
- Students who have successfully completed at least one year of study in a program taught in English are not required to provide an English score test, a document stating the duration and location of courses attended is required.



How to apply

The university degree LL.M in International and European Business Law at the University Jean Moulin Lyon 3 offers true flexibility to French, European and International students with **two possibilities a year: September and January**.

Application Form:

- Application deadline for January: November 30th
- Application deadline for September: June 30th

Tuition fees:

- D.U. LL.M in International and European Business Law (one academic year): 10,000 Euros + registration fees*
- Diploma in International and European Business Law (one semester), returning students**: 5,000 Euros + registration fees*

**Returning exchange students who have obtained the Postgraduate Diploma in International and European Law have the option of taking a further Semester of studies at the Law School for the purpose of obtaining the university degree LL.M. in International and European Law, subject to certain conditions set down by the Law School.

Students enrolled in the University Jean Moulin Lyon 3 receive a student card that gives them access to all university facilities and libraries of the institution.
